Seventh day of September one thousand seven hundred  
and ninety seven

The condition of the above obligation is such that if the  
above bound Henry Gullion & <sup>them</sup>  
their heirs &c shall well and truly pay or Cause to be  
paid to Rubin Samuel his heirs assigns &c the best and  
full Sum of Ninety pounds like money on or before  
the 15<sup>th</sup> July next then this obligation to be void other  
wise to remain in full force & Virtue in Law as  
Witness our Hands & Seals the day & year above written

The Condition of the above Obligation is such that whereas  
there did Issue on the 10th day of Oct. 1795 from the Office  
of the Clerk of the Court of the Franklin District a  
Capias ad respondendum John Brown Agree of Reuben Samu-  
el against Henry Gullion for the sum of one hundred and  
eighty pounds Debt & Damage the same returnable to the  
third day of the Dec. Court when Capias was this  
day and by Nat. Richardson Sheriff of Franklin on him the  
Henry Gullion. Now if the s. Gullion do well & truly  
appear agreeable to the Requisitions of s. Writ then the  
above Obligation to be void else to remain in full  
force power & Virtue
